Dashboards: Copy Tab

Summary

- Previously, users could copy sections on a Dashboard and move them to new tabs.
- While this helped streamline configuration, when there were multiple tabs with similar content manual configuration was still required to set up page filters on the new tab. Additionally, as Dashboards were increasingly tailored to different audiences or use cases, users needed a faster way to iterate, test variations, and re-use existing configurations.
- Now, users can copy Dashboard tabs, including page filters. This capability makes it easy to create variations, experiment with changes, or re-use proven best practice layouts.

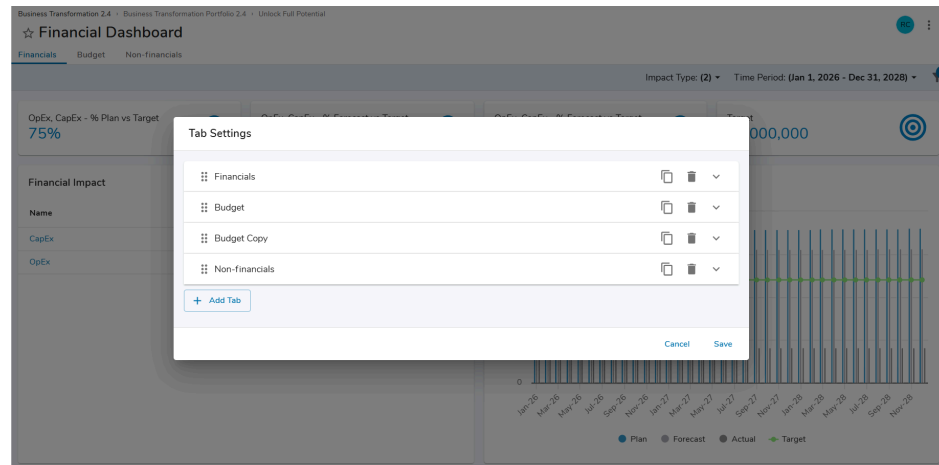

Set up

- On a Dashboard in which you hold an Admin role, select the 'More Actions' button in the top right of the page.
- Choose the 'Configure Tabs' option from the drop down.

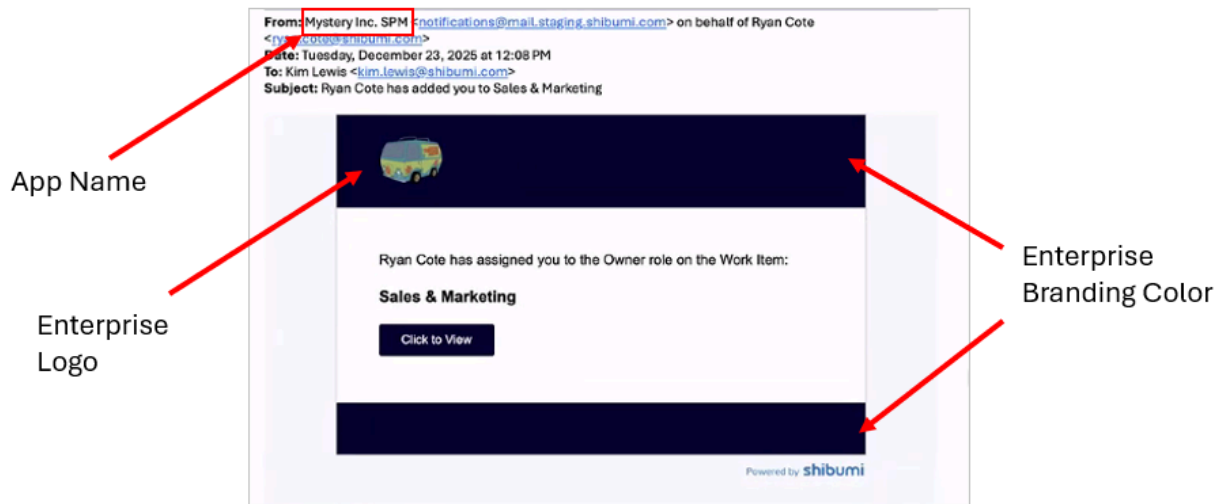
Set up cont.

- Select the 'Copy' icon on one of the existing Tabs.
- A 'Name Copy' tab will be created, providing the same layout configuration as the copied tab including Page Filters. Save.

Enhanced Email Format

Summary

- Previously, Shibumi notification emails included Shibumi corporate coloring and logo.
- Many organizations brand their Shibumi Enterprises with their corporate logos and coloring. Their users are familiar with this branding, so when emails arrive with Shibumi's logo there were concerns and confusion about the source of the emails.
- Now, email notifications have been enhanced to align with individual enterprise branding configuration. All notifications now use your organization's logo and primary branding color, and clearly identify the sender source using the App Name.



Sender and reply behavior has been standardized

- Role assignment notifications are sent from **[App Name]** on behalf of **[User Name]**
- Business Rule-generated notifications are sent from **[App Name]**
- Replies to user-initiated notification are delivered directly to the sender.

Table: Tree View

Summary

- Previously, Table sections could display hierarchical work items as individual rows or in a grouped format.
- To understand the associations to these work items (e.g., dependency relationships, alignment to strategic goals, etc.) a unique association table was required for each.
- Now, Release 241.0 introduces **Tree View**, a new tabular section that presents work items in a structured, expandable hierarchy and can also include associations. Tree View supports a true top-down load, allowing users to view higher-level items and progressively expand to child levels. Column data is displayed consistently across all row types (where attributes exist), enabling teams to assess progress, identify delays, and understand how delivery-level work contributes to overall objectives.

Set up

- On a Layout or Dashboard while in Configure mode, select '+ Add Section'.
- Under Table Options, choose the 'Tree' icon, a Tree View will be added.
- Select the Settings (gear) from the Tree View's section controls. On the General Tab, within the Sources section define the hierarchy for the Tree View. Choose from Direct Children, Descendants, or Associations.
- Once a source has been selected, the available next level sources are limited based on the selection. In the General Section, define Edit and Create Form settings, Preview Pane, Bulk Edit, and whether Choose Existing is available. Optionally, define section Filters.
- Save, select 'Customize' from the section controls. Select '+ Add Column' to add an Attribute, Calculation, or Timeframe column. Attributes shared between the various source types will display data in each row. Optionally, define Grouped Headers for the columns. Save and Publish.
